

ST ETHELBERT'S PARISH COMMUNITY 200 CLUB TERMS AND CONDITIONS

1. The name of the draw is "St Ethelbert's Parish Community 200 Club" ("the Lottery") regardless of the number of Members. The Church's Fundraising Committee will administer the Lottery.
2. The purpose of the Lottery is to raise funds ("the Funds") for St Ethelbert's Church, Bolton, BL3 5QJ ("the Church"). The Funds may be used for any purpose directed by the Church's parish priest in position at the time.
3. The Prize Fund is an amount equivalent to 50% of the total subscriptions, after reasonable expenses for the running of the Lottery have been deducted. The remaining 50% is payable to the Church as the Funds.
4. The Lottery shall commence on 1 January 2014 and continue until the Fundraising Committee confirms it is ended upon giving one month's notice to the Members. The first draw will take place on Sunday 5 January 2014.
5. A person who is a parishioner, friend or family of a parishioner or a member of the Parish Community (including staff or parent of pupil at one the Church's schools) and who is 16 years or older may become a member ("a Member").
6. A Member is allocated a permanent number by the Fundraising Committee for a subscription of £1.00 per week per number. A Member may have more than one number. A record of names and numbers will be held in the Church.
7. A Member shall pay their subscription in advance by cash or by cheque made payable to 'St Ethelbert's Church'. If a Member has not paid their subscription for 2 weeks, their number shall be removed from the following draws until payments have been made. If a Member has not paid their subscriptions for a period of 6 weeks, they will be removed as a Member and their number(s) may be reallocated.
8. Each number allocated to a Member will be entered into a draw each week ("the Weekly Draw"). The Weekly Draw will take place each Sunday in the presence of 3 people present in Church that day. The winner will be the Member who has their number drawn in the Weekly Draw. The prize for having the winning number drawn in the Weekly Draw is £50.
9. In addition there will be a further draw four times each calendar year ("the Additional Draw"). The Additional Draw will take place on the last Sunday in March, June, September and December in each calendar year. A Member will have their number entered for the Additional Draw provided they have been a Member since the date of the previous Additional Draw or 1 January 2014 whichever is the later. The prize fund for the Additional Draw will be a sum calculated as follows: Fifty percent of the total subscriptions for the period from the last Additional Draw or 1 January 2014, (whichever is the later) including the subscriptions for the date of the Additional Draw, after deduction of reasonable expenses for the running of the Lottery, minus the total winnings of the Weekly Draw for that same period to include the Weekly Draw winnings from the date the Additional Draw is made ("the Additional Prize Fund"). The Fundraising Committee will decide how many winners there are to be from the Additional Draw and the amount of the winnings based on the value of the Additional Prize Fund available at each Additional Draw.
10. The results of each draw will be put on the Church notice board and in the Church's newsletter. The winnings will be available for collection in Church following the draw. The winner must provide evidence of identity and their Lottery card upon collecting the winnings and sign for receipt of the winnings. A Member winning a Weekly or Additional Draw and owing any subscriptions will have the amount owing deducted from their winnings. The Fundraising Committee will keep a list of winners and subscriptions for a period of one year after each payment or subscriptions. Where a Member has not collected their winnings within 6 months from the date of the winning draw, the Fundraising Committee may put the winnings back into the prize fund and the winning Member may not claim the winnings.
11. A Member may cancel their membership by giving one month's notice to the Promoter in writing.
12. The Lottery is intended to be a small lottery under the Gambling Act 2005. The Promoter of the Lottery is Bernard Lewarne (member of the Fundraising Committee) c/o, St Ethelbert's Presbytery, 67 Wigan Road, Deane, Bolton, BL3 5QJ.
13. The decision of the Fundraising Committee in any matter requiring adjudication shall be final. The Fundraising Committee may amend or revoke any of these rules upon giving reasonable notice.
